1. The tender is invited for printing and supply of packaging materials for the Agro Processing Centre. The item-wise specification and quantity are provided in Annexure-I.
2. The quoted rates shall be **inclusive of excise duty, packing & forwarding, transportation, and delivery charges to:**

3. GST should be clearly mentioned separately in percentage in the price sheet.
4. Each bidder shall submit only **one bid** covering all items. Conditional or alternative offers shall not be accepted.
5. Prices shall be quoted **only in Indian Rupees (INR)**.
6. Delivery of materials must be completed within **15 working days** from the date of issue of the Purchase Order. Orders may be placed in a phased manner depending on requirement.
7. **Penalty for Delay:** In case of delay in delivery, liquidated damages @ **0.5% per week or part thereof**, subject to a maximum of **10% of the total order value**, will be deducted from the payment due.

8. Eligibility Criteria

- a. Attested copy of GST Registration Certificate.
- b. The firm must be engaged in printing of packaging materials (for pulses/spices or food processing units).
- c. The firm must have a registered office or shop in India.
- d. The tender must be properly signed and stamped on all pages.
- e. Bids must conform to all terms, conditions, and specifications.
- f. Conditional or alternative bids will be summarily rejected.

9. Issue of Purchase Order

- a. The Purchase Order will be issued to the bidder whose tender is found **substantially responsive** and who has offered the **lowest evaluated price**.
- b. The Purchase Order shall remain valid for a period of **one year** from the date of acceptance, and the **price shall remain firm** during this period.
