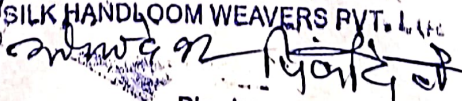

**TERMS AND CONDITIONS**

1. The tender shall be for the full quantity of all item(s) as described in the schedule of requirement in **Annexure- I**. The format for Technical & Price bid is specified in **Annexure- II & III** respectively, which should be used at the time of submission of tender. Corrections, if any, shall be made by crossing out, initialing, dating and rewriting. NIT Tender Paper should be signed and stamp as a token of Acceptance of Terms and Condition of the Purchaser.
2. The quoted rates (in INR) shall be including the GST and the bidder's cost towards delivery at consignee places, packing & forwarding, transportation (Loading/Unloading) and delivery charges to the project site/Location at Thakurganti Mandro Sakhi Silk Handloom Weavers Pvt Ltd. at Vill-Kandhar, PO- Bhagaiya, PS- Meharna, Block-Thakurganti, District – Godda, Jharkhand, 813208.
3. GST and any other local taxes should be clearly mentioned separately in terms of percentage/in figures in the price sheet.
4. Each bidder shall submit only one bid for the entire package or any one package; alternative bid or conditional offers shall not be accepted.
5. Tenders/Price shall remain valid for a period not less than 90 days from the date of opening of the technical bids.
6. The delivery should be completed within 20 working days from the date of receipt of the purchase order.
7. Any delay by the supplier in the delivery of the items shall render the supplier liable to be charged liquidated damages @ 0.5% per week or part thereof subject to a maximum of 10% of purchase order value which will be deducted from the payment due.
8. **Eligibility criteria & documents required for the technical bid.**
  - (a) Copy of GST Registration certificate.
  - (b) Minimum 03 years of experience in supply of silk or textile raw materials.
  - (c) Valid PAN and GST registration (GST exemption, if applicable, to be clearly mentioned.
  - (d) Financial turnover during last 3 financial years (as specified in bid data sheet.)
  - (e) Single price for each item.
  - (f) Alternative price/conditional offer shall not be accepted.
  - (g) Not blacklisted by any Government / PSU / Autonomous body.
  - (h) Rate should be quoted as per the format for the full quantity of all items as mentioned in Annexure-III.
  - (i) Signed and stamped Tender documents (as acceptance to the terms and conditions) to be enclosed with the technical bid.
  - (j) Bid security amounting to Rs. 10,000.00 (Rupees Ten Thousand Only) to be enclosed in the technical bids in shape of Banker's Cheque or Demand Draft in favor of "Thakurganti Mandro Sakhi Silk Handloom Weavers Private Limited" payable at Bhagaiya.
  - (k) In the Technical bids should not be mentioned anything related to price, otherwise the bids shall not be taken into consideration.
  - (l) Bids receive late due to any reasons; it will not be opened and returned to the bidders.

**10. Submission of bid.**

The bidder should submit their tender in a sealed envelope and the envelop consisting of two separate envelopes e.g. (1) Technical bid and (2) Financial bid and both the envelope should be put in a single envelop.

**11. Evaluation:**

The Technical bid will be opened first by a committee and to be evaluated in accordance with the terms and conditions of the tender. Those bids found technically responsive, only their financial bid shall be opened in presence of the bidder.

**Issue of Purchase Order.**

12. The Purchase Order will be placed to the selected bidder, whose bids has been determined to be substantially responsive and who has offered the lowest evaluated package price. The terms of the accepted offer shall be incorporated in the purchase order

13. Any effort by a bidder to influence the purchaser in its decision on bid evaluation or placement of purchase order may result in rejection of the bidder's offer.

14. The tender will be opened at the PE Office at 15.30 hours on the last date specified for submission of tender in presence of the bidders or their authorized representative. In case the last date of submission is a holiday or office closed, the last date and time for submission of the tender should be the immediate next working day.

**15. Payment Terms**

Payment shall be released after receipt, inspection and acceptance of materials.

Payment will be made by the tender inviting authority within 30-45 working days after submission of bills along with another relevant document as per tender/contract.

16. Any legal dispute arising out of this is subject to Godda jurisdiction only.\_

17. Notwithstanding the above, the purchaser reserves the right to accept or reject any bid(s) and to cancel the bidding process at any time prior to the issuance of Purchase Order without assigning any reason.

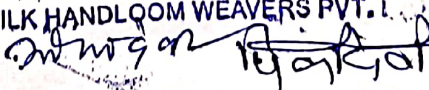

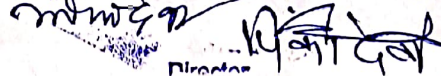

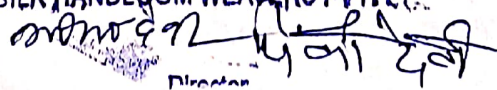
